

NOMINATION FORM

President Elect/President 2014 – 2016

ALL is seeking nominations for the role of President. The constitution of the Association is about to be changed and in future the role of President will be of two years' duration with an additional year as President Elect before assuming the President role. However, due to this change in the constitution the nominations process has been delayed. Thus the person elected as President Elect in early 2014 will begin his or her presidency in September 2014.

Cycle:

Year 1: An induction phase as President Elect

Years 2 & 3: An action phase as President

ALL is managed by a Board of Trustees (Management Board) which is responsible for the financial, legal, charitable and business aspects of ALL's work. At any time there are three elected officers of ALL (President Elect, President and Membership Officer) on the Board. Other places on the Board are taken by five invited trustees, one of whom is Chair. The ALL Management Board is currently chaired by Richard Fairbairn. The Chair also acts as Treasurer of the Association. The Board works closely with the staff of the Association to determine the strategic development of ALL. It meets four times a year.

The new President Elect will be part of the Board, first as an observer (January – August 2014), then as a full trustee from September 2014 – August 2016. ALL trustees assume considerable responsibility for the Association. They are insured against liability and, provided duties are carried out in accordance with the law, bear no personal risk.

The President will have to make a commitment to the Association of approximately 45-50 days over three years. The duties are set out in full in the accompanying documents.

Facts

- Candidates must be full individual members of the Association.
- Candidates/nominators are required to complete a Nomination Form, which must be signed by three supporters who are full individual members of the Association.
- Candidates are able to nominate themselves provided they have the required signatures in support.
- In the event of a ballot, this will be run by the Association using the single transferable vote system.
