

### **Powerful new partnerships launched for languages support**

Following productive discussions with the coalition Government about the future of support for language teaching and learning, CILT, the National Centre for Languages is to merge with the education charity CfBT Education Trust with effect from today. Its branch in Cardiff, CILT Cymru, which is funded by the Welsh Assembly Government, will continue to provide services to teachers in Wales by merging with the WJEC. The brands and core objectives of both CILT, the National Centre for Languages, and CILT Cymru will remain unaffected.

Kathryn Board, Chief Executive of CILT, said:

"We are delighted that the DfE and the Welsh Assembly Government have supported us in achieving these new partnerships which will strengthen our ability to meet the needs of schools and further develop the support for languages which is so desperately needed. CfBT and WJEC are both excellent organisations which will add enormous value to our work. By combining our operations in this way we will be able to make the most efficient use of public funds and provide teachers and schools with the help, advice and support they need to expand and improve languages teaching."

Neil McIntosh, Chief Executive of CfBT said:

"CILT's expertise and track record in the field of language teaching are internationally recognised. We are delighted that this essential work will continue - and be developed further - within the framework of the CfBT. Together we can offer an even wider range of support for languages which will enhance education in schools and enable young people increasingly to use languages in their future careers in business and the public services."

From today the majority of CILT services including: the Graduate Teacher Programme, CILT Plus, the online membership community offering expert support and guidance on language learning, CPD and resources; and programmes currently funded by the DfE, will transfer as a unit to CfBT along with staff working on these activities and the CILT brand.

### Notes for Editors:

1. **CILT** ([www.cilt.org.uk](http://www.cilt.org.uk)) was established on 25 August 1966 by the then Department for Education and Science as the Centre for Information on Language Teaching, for 'the promotion of education by means of the collection of information on all aspects of modern languages and the teaching of modern languages and the making available of such information to such persons or bodies of persons as may be concerned with the educational interest of the people of the United Kingdom'. Following the demise of the Committee on Research and Development in Modern Languages and the transfer of some of its responsibilities to CILT, it was renamed the 'Centre for Information on Language Teaching and Research' in 1971. Following the publication of the National Languages Strategy in 2002 CILT announced its intention to merge with its close partner the Languages National Training Organisation (LNTO) to become CILT, the National Centre for Languages. This process was completed in 2005. Following Kathryn Board's appointment as CEO, the organisation has been pursuing a strategy of partnership development and diversification of its income base to achieve financial independence from the DfE, a process which has culminated in the measures announced today. CILT's vision is a society where everyone recognises the value of languages and intercultural relationships and is able to use more than one language.
